RESOLUTION NO. R12-1819

RE-CERTIFYING TRUSTEE AREA MAPS

WHEREAS, the Governing Board of the Kingsburg Joint Union High School District ("Board") is composed of five (5) members;

WHEREAS, the District is located in Fresno, Kings and Tulare counties;

WHEREAS, since the majority of the District's territory lies in Fresno County, the Fresno County Committee on School District Organization ("County Committee") was the entity required to approve changes to the Board's election system;

WHEREAS, Kings County was then under the jurisdiction of the Department of Justice as a Section 5 Pre-Clearance County, requiring the District to obtain approval for all proposed voting changes from the Civil Rights Division of the Department of Justice;

WHEREAS, Mr. Brent Lunde resides at 5700 Bangor Avenue in Kingsburg, California and he has continuously resided there since 2002. Mr. Lunde ran for a position on the Governing Board and was first elected to an at-large position in 2006. Member Lunde was re-elected to an at-large position in 2010;

WHEREAS, District based elections were first conducted in 2012 in Trustee Areas 1 and 4. District based elections were first conducted for Trustee Areas 2, 3, and 5 in 2014. Mr. Lunde was elected to represent Area 2 in the 2014 election and is running again in the 2018 election to represent Area 2;

WHEREAS, in preparation for the 2018 election, the Kings County Registrar of Voters has questioned whether Board Member Lunde's residence on 5700 Bangor Avenue is in Area 2 or Area 3 and has asked the Governing Board to re-certify its trustee area maps to confirm whether Mr. Lunde's residency;

WHEREAS, On March 11, 2010, the Board adopted Resolution No. 15-0910 to change from atlarge to by-trustee area elections;

WHEREAS, On October 17, 2011, the Board reaffirmed its commitment to district based elections and, using 2010 census data, considered three maps drawn by the District's demographic consultant, Douglass Johnson of National Demographics Corporation. The Board selected Map No. 1 of three proposed maps, by adopting resolution R17-1112;

WHEREAS, on January 12, 2012, the State Board of Education granted Waiver No. 51-10-2011-W-4 waiving designated sections of the Education Code and eliminating the need to obtain voter approval of the change from at-large to district based elections;

WHEREAS, on April 11, 2012, the Fresno County Committee conducted the required public hearing on the District's proposal. On page five (5) of the presentation to the County Committee, Trustee Lunde is identified as residing in Trustee Area 2;

WHEREAS, on April 11, 2012, the County Committee approved the District's requests, formally adopting Resolution No. 2012-04 and allowing the District to move to district based elections using Map No. 1. Maps of each of the five (5) newly created districts were sent to the election offices in Kings, Tulare and Fresno Counties. The maps that were adopted by the District at that time show Trustee Lunde residing in Trustee Area 2;

WHEREAS, on June 21, 2012, the Civil Rights Division of the U.S. Department of Justice granted section 5 pre-clearance approval as authorized by the Voting Rights Act through letter No. DJ 166-012-3 2021-2428;

WHEREAS, in October of 2018, the Kings County Registrar of Voters provided Mr. Lunde with the names and addresses of the registered voters in Trustee Area 2 and Mr. Lunde's address at 5700 Bangor Avenue is shown to be in Trustee Area 2;

WHEREAS, when questioned about whether Mr. Lunde resides in Trustee Area 2 or 3 in October of 2018, the Superintendent asked the District's demographer to examine the District's maps and re-verify where Mr. Lunde resides. Mr. Johnson confirmed that Mr. Lunde resides in Trustee Area 2; and

WHEREAS, at the Superintendent's request, Mr. Johnson sent the District maps depicting the same boundaries as the maps adopted by the Board on October 17, 2011 and approved by the County Committee on April 11, 2012 but capable of being enlarged enough to determine the location of Mr. Lunde's residence. An examination of those maps indicates that Mr. Lunde resides in Trustee Area 2.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

- 1. The recitals set forth above are true and correct;
- 2. Trustee Lunde has resided in Trustee Area 2 since its creation in 2012;
- 3. Trustee Lunde continues to reside in Trustee Area 2 of the District's adopted map as set forth in Resolution R17-1112 adopted by the Board on October 17, 2011 and as approved by the County Committee on April 11, 2012.
